Approval of Minutes

If approved by the Academic Council, the recommendation would be submitted to the Administrative Council and the Board of Regents for their approval. If approved by these parties, the courses would be submitted to the Texas Higher Education Coordinating Board for review and approval.

2. Dr. Camacho made a motion to adopt the following proposal for a differential fee in Music.
Dr. Garrison seconded; and the motion was adopted. (closed)

The Fine Arts College Council voted to recommend a proposal for a fee structure that charges a \$16 per semester credit hour fee for MUSC and AMUS classes with the exception of MUSC 1033, Appreciation of Music. If approved, they would like the differential fee to become effective in spring 2015.

Rationale for Establishing a Differential Fee: The approval of a differential fee for music will primarily allow students to cover the piano accompanying needs for their applied lessons and recitals through the university established financial channels, making this expense an integral part of the academic program and part of the student's financial aid and its related benefits. Currently, students pay out of pocket for external hires to play during their weekly per credit lessons and required recitals.

Strategies for advocating on behalf of students to overcome impediments to their success are presented.**

- **Understand effective termination skills.**

- **Develop openness to hearing feedback from others and skill in giving feedback to others in regards to your perceptions and impact on students.**

- **Become articulate in describing your view of how the helping process works and how your personal style is naturally effective and is sometimes adapted to meet students' needs. Understand the place of empirical research in the practice of counseling.**
- **Be able to search for research articles and to articulate the findings of several articles on the same topic.**
- **Address some of the significant professional issues in becoming a helper (values, diversity, ethics, personal issues) and assist students in utilizing this information as a means to enhance self-awareness, knowledge and skills.**

Option I - Master of Education in School Counseling

Mission Statement: The graduate program in school counseling will equip the counselor with the knowledge and skill necessary to supply guidance and counseling services in a school setting. The school counselor will be able to provide direct counseling to students; consult with parents, teachers and administrators; act as a liaison between the school and outside agencies; and facilitate classroom guidance activities.

The graduate program in school counseling prepares students to be public school counselors and requires 60 semester hours. Students are required to pass a comprehensive exam as a program completion requirement. Texas Counselor certification requires completion of an approved master's degree, two years of teaching experience, and a passing score on the state mandated examination, the TExES test and an internship in a school setting. Enrollment in courses with the COUN prefix (with the exception of COUN 6013) requires admission to the Master of Education in school counseling program or permission of the Counseling Program Coordinator.

~~Temporary Permit to Register with Unofficial or Missing Transcripts:~~

~~Students may request a temporary permit to register if the Office of the Graduate School has not received all transcripts. Students must present a transcript with proof of a bachelor's degree conferred prior to enrollment in a graduate program. If a temporary admission status request is granted by the graduate coordinator, all official, final transcripts must be received no later than 30 calendar days after the first day of class. An incomplete credentials hold will be placed on the student's file preventing future registration until all transcripts are received and the student has been admitted into a graduate program. If official transcripts are not received prior to the last day for an official withdrawal, the student may be administratively withdrawn from the University. Students who register in this manner assume all responsibility for course prerequisites and eligibility. Note: Not all University departments allow temporary admission into their graduate programs.~~

Unconditional Admission

An applicant who meets each of the following admission criteria may be eligible for unconditional admission by the graduate faculty of the student's intended major:

1. A bachelor's degree from a regionally accredited institution. (The equivalence of foreign degrees is evaluated by the Office of International Services.) The Graduate School must receive an official transcript, including one on which a bachelor's degree is posted, directly from each institution the applicant has attended.
2. A cumulative undergraduate GPA of at least 3.0 from the student's graduating institution.
3. A competitive score on the standardized graduate test, if required by the graduate program. The requirement for standardized test scores is decided at the college level. The student should contact the graduate coordinator of the intended graduate program

for information. The Graduate School must receive official admissions test scores directly from the organization that administers the test.

4. An undergraduate background judged by the graduate faculty of the student's intended major to be adequate for success in the student's intended major.

Conditional Admission

An applicant who does not meet each of the above admission criteria may be eligible for conditional admission by the graduate faculty of the student's intended major if the applicant has the following:

1. A bachelor's degree from a regionally accredited institution. (The equivalence of foreign degrees is evaluated by the Office of International Services.) The Graduate School must receive an official transcript, including one on which a bachelor's degree is posted, directly from each institution the applicant has attended.
2. An official score for the standardized graduate test, if required by the graduate program. The requirement for standardized test scores is decided at the college level. The student should contact the graduate coordinator of the intended graduate program for information. The Graduate School must receive official admissions test scores directly from the organization that administers the test.

A student who is conditionally admitted must earn a grade point average of 3.0 or better in the first four graduate courses (which total at least 12 SCH) applicable to the student's graduate major. Students who are assessed additional undergraduate leveling work must complete that work at the direction and to the satisfaction of the coordinator of the student's graduate major. To continue in the program, the student must meet the conditions set forth in the conditional admission.

Provisional Admission

A student may be admitted in the provisional admission status if the official transcripts have not been received in the Graduate School in a timely manner to facilitate admission decisions. To be considered for this admission status, students must present a transcript with proof of a bachelor's degree conferred. Final transcripts must be received no later than 30 calendar days after the first day of class in the semester in which a student matriculates. An incomplete-credentials hold will be placed on the student's record preventing future registration until all transcripts are received and the student has been admitted into a graduate program. If official transcripts are not received prior to the last day for an official withdrawal, the student may be administratively withdrawn from the University. Students who are administratively withdrawn are only due refunds in accordance with the MSU refund schedule. Not all graduate programs offer provisional admission status.

12. Ms. English presented the following points of information regarding previously approved undergraduate course and catalog changes. (*closed; no vote required.*)

From the March 2014 Minutes:

Dillard College of Business Administration

- Finance (move notation of "if not taken in the Professional Business Core" from FINC 4653 to ECON 4643.

West College of Education

- Education front portion... under Admission to the Teacher Certification Program, 2nd paragraph after numbered list, beginning with "All students must satisfy the basic skills..." There are three courses listed in this paragraph that are no longer in our course inventory and should be removed: EDUC 4173, 4466, and 4473.

- Education, Science 4-8 Certification, under Teaching Field (Major), GEOS 3134 was listed as Oceanography, but the correct course number for Oceanography is GEOS 3034. -- also in this same area, under Block B, it still shows must finish Blocks 1 and 2, should be Foundation Courses and Block A.

- Education, Bilingual Generalist, under core, it shows "Choose 3 hours from the following courses" and it only lists ART 1413 and MUSC 1033. THEA 1503 should also be listed as a choice.

- Secondary Teacher Certification - 3 paragraphs, end of third paragraph says "An additional teaching field is offered in French." But several pages later the other teaching field in French is marked out. So, this last sentence should also be removed.

- Secondary Certification - BA core requirements: the core listed here is 42 hours, which is the exact the number of hours for the core. So, the new added text of "plus additional requirements" should not really be added.

- English Language Arts & Reading (7-12), under Major there is a note about 6 hours being duplicated... need to remove "plus additional requirements".

- Social Studies (7-12), under Major there is a note about 6 hours being duplicated... need to remove "plus additional requirements".

- Social Studies (7-12), under Interdisciplinary Minor there is a note about 6 hours being duplicated... need to remove "plus additional requirements".

- Social Studies (7-12), under Foundation Courses, change THEA to TSI.
-- also in this same area, under Block B, it still shows must finish Blocks 1 and 2, should be Foundation Courses and Block A.

- Life Science 7-12, under major, it shows 3634 as Invertebrate Zoology, but the correct number is 3644.
- KNES, BA, all-level, Elective - 1 hour, should be specifically a EXPH activity course.
- KNES, BS, all-level, Other Area Emphasis shows GEOL 1134, 1234, should be GEOS.

Fain College of Fine Arts

- Music, BM, all-level, for both the vocal and instrumental emphases: the core listed here is 42 hours, which is the exact the number of hours for the core. So, the new added text of "plus additional requirements" should not really be added.
- Theatre, BFA, all-level: the core listed here is 42 hours, which is the exact the number of hours for the core. So, the new added text of "plus additional requirements" should not really be added.
- Theatre, BFA, all-level: After Other Requirements and before Major in Theatre, there is an italicized note about grades of D not being accepted for "Theatre Core or Additional Theatre Requirements". It should be changed to "the Major in Theatre".
- Theatre, BFA, all-level: In the Major in Theatre section, THEA 3143 should be titled Stage Management (not Movement), and THEA 4121 should have "II" in the title, not "I".

Gunn College of Health Sciences and Human Services

- Athletic Training – under Clinical and Field Experience, ATRN 3101 and 3901 should be ATRN 3111 and 3911.
- Radiologic Technology – under Progression Policy for the BSRT Program, #5 mentions RADS 2114, this should be changed to RADS 4114.
- Also Radiologic Technology – under Major (78 hours), RADS 3233 should be RADS 3243.

Prothro-Yeager College of Humanities and Social Sciences

- SOCL 2233 course title change is marked effective Spring 2015, but it has to be for Fall 2015.
- BAAS – Option B: Criminal Justice Emphasis, under Professional Development, SOCL 3353 was listed. This course was deleted from course inventory by the Sociology Department so it should not be listed in BAAS as a course option.

College of Science and Mathematics

- Biology – Majors, ²Advanced Zoology courses, BIOL 3133 was deleted from course inventory and should be removed from this listing.

- Biology, Program Requirements, Option E2, they have CHEM 2001/2003 listed both in required courses and as electives. The CHEM listed in the electives section should have been CHEM 2011 and 2013 instead.

From the May 2014 Minutes:

Gunn College of Health Sciences and Human Services

- Social Work Major (62 hours) – SOWK 3223 should be 3233

-- also, SOWK 4203 is listed twice in the electives – or SOWK 4203 should be removed

Additional Information

- Dr. Garrison announced that the Billie Doris McAda Graduate School Open House was today at 5:30 p.m. in Dillard 189.
- Dr. Garrison reported that graduate enrollment numbers are up.
- Mr. Wong reminded everyone that the State Employee Charitable Campaign (SECC) is still going on. He thanked Dr. Stewart and Dr. Patton for speaking at the kick-off function on September 24.
- Dr. Latham announced that the Faculty Book Plating Ceremony will be Thursday, October 30, at 3 p.m., in Moffett Library. There are 14 recipients this year and she invited everyone to attend.
- Ms. English stated that Early Registration begins November 3.
- Dr. Capps reported that the state has a high school organization called Texas association of future educators which is comprised of high school students who want to be teachers (currently 1,500 statewide). Region 9 does not have schools that do this but we are going to help start them by serving as a college sponsor. In addition, we are starting a college version which is new to this state, through the future educators association.
- Dr. Camacho announced the following Fine Arts events:
 - October 9-12 – Theatre production “August in Osage County”
 - October 21 – The University Singers (Choir Concert), Akin Auditorium
 - October 24 – MSU Wind Ensemble performance, Akin Auditorium
 - October 31 – Faculty Art Exhibition in the Juanita Harvey Art Gallery
