TERMS: I request the ETFL to defer up to 100% of my tuition, fees, housing and board expenses for Fall 2025. One-half (1/2) is due on or before 4:30 p.m., September 24, 2025 and one-half (1/2) is due on or before 4:30 p.m., October 22, 2025. I also agree to pay a loan origination fee of \$22.50 plus a service charge of 1%.

CONDITIONS:

- Payments must be received by MSU Texas on or before the due dates stated above.
- There will be a late fee of \$30 assessed if the payments are not received by the payment due dates.
- Payment by web check (ACH), MasterCard, VISA, American Express, or Discover may be made online through the student portal at <https://login.msutexas.edu>. Login and select the Touchnet link. The Business Office window accepts cash, personal check, cashier's check, or money orders.
- If the student payment is returned by the bank as Insufficient, the student may be dropped from their classes. The payment and a \$30 returned check charge is due immediately.
- As mandated by the MSU Texas Board of Regents, unpaid balances will be turned over to a collection agency and reported to a credit reporting agency. A collection fee of 30% of the outstanding balance will be added to the student's account.
- Once a payment plan is selected, it cannot be changed.

- I acknowledge and accept responsibility for all debts plus any fines and/or collection fees owed MSU Texas.
- I will update changes to my email and/or cell phone number as needed.
- I will not be allowed to register for any future enrollment semesters until all debts to MSU Texas have been paid.
- I will not be allowed to receive an academic transcript for any work completed at MSU Texas until all debts have been paid.
