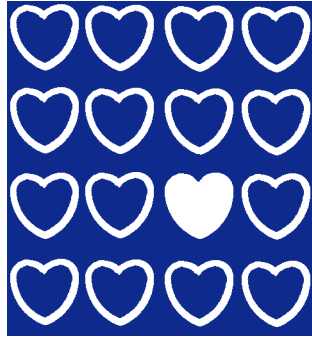

## **“When Investigations Fail...Wrongful Convictions”**

Criminal and administrative investigators make decisions and come to conclusions potentially profoundly impacting the lives of persons under investigation. From the first exposure to an allegation, investigators begin constructing a narrative. Participants will explore cognitive biases and unconscious psychological pressure to look for evidence that fits within the narrative and reject evidence that does not. In addition, we will explore the differences between lawful interview and interrogation techniques as opposed to coercive techniques leading to false confession.

**Kevin DuBose** – Kevin earned his BSCJ at Midwestern State University in December of 1992 and an MSCJ at Texas State University in May of 2007. While earning the MSCJ, he wrote a thesis entitled, “Continuum of Coercion: Staff Sexual Misconduct in Departments, Programs and Facilities in Texas”. He has been a commissioned peace officer since 2009.

Kevin began his career in juvenile justice with the Wichita County Juvenile Probation Department in 1995. He supervised pre-adjudication and post-adjudication caseloads. In 1998, he left juvenile justice to serve as a District Parole Officer out of the Wichita Falls District Parole Office for the Texas Department of Criminal Justice. He supervised specialized caseloads, including violent offenders. Kevin resumed his career in juvenile justice in 1999 with the former Texas Juvenile Probation Commission. He is currently the Assistant Chief Inspector General over administrative investigations for the Texas Juvenile Justice Department's Office of Inspector General.

## **“Supporting Male Survivors of Sexual Violence”**

This workshop gives an overview of the unique challenges male survivors of sexual violence face, dispels the harmful myths that discourage both boys and men from coming forward, and presents best practices for improving the chances of successful interactions with male victims.

**Emiliano Diaz de Leon** – After more than a decade of experience working for several domestic and sexual violence centers across Texas, Emiliano joined the Texas Association Against Sexual Assault in 2008 and provides training and technical assistance on primary prevention of sexual violence to Rape Prevention Education (RPE) grantees around the state. In addition Emiliano provides training and technical assistance on enhancing services to male survivors of sexual violence to individuals and organizations in Texas and around the country.

## **“Vicarious Trauma & Self Care”**

Counselors bring their strengths and vulnerabilities with them wherever they go and use their skills and empathy at work with clients and peers, out in public and at home with family and friends. Counselors care for others before they tend to themselves. Ignoring one's personal stressors can have a snowballing affect that can lead to burnout and impair a counselor's effectiveness in all areas of life. Impairment doesn't always take an obvious form. This session will look at some ways to flourish psychologically, physically, spiritually, emotionally, personally and professionally in order to conquer the challenge of maintaining competence and providing quality care to those we serve and love, including ourselves.

**Wende Hilsenrod** – Wende has been a Training Specialist at Texas Association Against Sexual Assault since 2005, providing training to new advocates at sexual assault programs, and speaking at conferences statewide. With a B.S. in Communication Sciences and Disorders, B.S. in Psychology and an M.A. in Human Services, Wende has worked across Texas helping communities understand the impact of abuse on survivors since 1993. She began her career as an Advocate on The Family Violence Protection Team in Austin, where the importance of working with the entire family and community was emphasized. She has also been a guest lecturer at Texas State University School of Forensic Sciences, trained at State and National Conferences, and in Mexico. Wende is a member of the Central Texas Coalition Against Human Trafficking, the Texas' Office of the Attorney General Human Trafficking Task Force and a member of TDCJ-TVAT Academy.

## **“Sexual Assault Perpetrator Analysis and Suspect Interrogation”**

Interviewing Sex Offenders begins with the art of active listening and evolves into a behavior analysis of sexual predators studying the different typologies of the offenders. Having this understanding of typologies allows for the investigator to better prepare for an interrogation. We will examine interrogation techniques such as Kinesics, Neuro-Linguistic Programming and Proxemics and pull them together into a very comprehensive 8 step interrogation that increases the ability to gain confessions and reduces any chance of false confessions.

**Michael Sweeney** – Michael is a Training Specialist for the Texas Association Against Sexual Assault and has 28 years of experience in law enforcement in narcotics, logistics and operations, internal affairs and human trafficking. In 2008, Mike attended and graduated the 233rd Session of the FBI National Academy, specializing in interview interrogation and statement analysis, and was able to apply those skills in his work as Director of Investigations and Law Enforcement Development for International Justice Mission in Ghana, Africa. Mike has been a human trafficking training specialist at TAASA since August, 2017, where he is a frequent keynote speaker at statewide conferences, and a trainer of law enforcement and criminal justice professionals. His trainings are centered on trauma-informed investigations of human trafficking and sexual assault.

## **“Ethics”**

Ethical conduct, or the lack thereof, has found its way to the center of the public debate. Some rules and conventions that have been in place for decades are today, at times being routinely ignored. And some ethical issues that have long been ignored have found a voice, leading to the loss of careers and positions at the very highest levels of the culture.

As helping professionals, we remain “helping” only when the people we serve and the people we work with are regarded consistently with respect and healthy boundaries are maintained. This seminar will focus upon 1) Standards, rules, guidelines and laws designed to protect those we serve and serve with; 2) Ethical decision-making in situations where ethics are murky or in conflict with one another; 3) The use of intentional ethical philosophy to enliven and give meaning to the work of the helping professional.

**David Sabine, Ph.D.** – Dr. Sabine is a Clinical Psychologist in private practice in Wichita Falls for over 20 years. He is also a seminary graduate whose primary training was in the Philosophy of Religion and Ethics. He is the author of A Chair with a View: Scenes of Heartbreak and Breakthrough in Psychotherapy. He has also been interviewed on national top ten radio shows and has been published in numerous publications nation-wide. Dr. Sabine also is regularly called upon to testify as an expert witness in court proceedings and is consulted routinely on issues of ethics as they relate for forensic issues.

## **“Suicide Risk and Intervention Training”**

Recently our community has experienced an increased rate of suicidality and need for mental health evaluation and treatment. As a result, the need for informed citizens, in the assessment and treatment of people experiencing a mental health crisis, has grown. Suicide prevention techniques, warning signs, facts, statistics, and knowledge of community resources will all be part of this training.

**Charles Martin** – A native of North Texas, Charles Martin has been an integral part of the state mental health system since 1995. Working with adults, children and adolescents, while managing a staff of caseworkers, has given him insight to both patients and clinical behavioral health specialists. Charlie is currently serving as the Director of Crisis Services for the Helen Farabee Center. As director, he oversees mobile assessments, admissions, evaluations, community resource placement, and development of staff in the entire North Texas region. Charlie facilitates professional trainings in prohibiting access to lethal means, fundamentals of case management, and crisis intervention techniques.

## **“HIV, AIDS, Communicable Diseases - Sexually Transmitted Disease and HIV/AIDS/STD/HEP/TB”**

Participants will be presented with information on the epidemiology of sexually transmitted disease, differentiate between viral, bacterial and protozoan sexually transmitted infections and prevention. Participants will also learn about the symptoms and modes of transmissions of Hepatitis A, B, C, HIV/AIDS, TB and some of the more prominent sexually transmitted diseases. This session will be specific to counties served by the Wichita County Health Department. Wichita County Health Department presenters will discuss HIV/AIDS services for the Wichita County and surrounding counties as well as immunizations and current statistics and trends regarding Flu, Ebola, Zika, and any other current news making illnesses.

## **“IN HER SHOES”**

### **Pt. 1: In Her Shoes**

In Her Shoes is a simulation activity for participants to move, do, think, and experience the lives of women in abusive relationships. The simulation is designed to teach about the dynamics of domestic violence, the resources available to a victim, common reactions a victim faces in her community, and the typical obstacles a victim encounters when interacting with various systems.

**Jordyn Lawson** is the Assistant Director of Clinical and Professional Services at Genesis Women's Shelter and Support. Jordyn has worked in the field of domestic violence recovery for over 10 years. She currently provides individual and group counseling services to women and children victims of domestic violence and trains community members on the dynamics of abuse.

### **Pt. 2: “Domestic Violence 101 and Safety Planning”**

What is domestic violence and what can I do to help? This presentation will cover the dynamics of abuse in intimate relationships and common myths associated with domestic violence. Attendees will explore why a victim might stay in an abusive relationship and brainstorm several ideas on how a victim can decrease the risk of harm.

**Ruth Guerreiro, LCSW** – Ruth is a Licensed Clinical Social Worker, Board Approved Supervisor (LCSW) and has been practicing since 2004. She is certified in EMDR, and trained in CPT, TF-CBT, and other forms of talk and play therapy. Ruth's expertise includes trauma, attachment, domestic violence, and parenting. Ruth is the Director of Clinical and Professional Services at Genesis Women's Shelter and Support. She also sees women and children in individual, group and family sessions, in both English and Spanish.

### **Pt. 3: “Every Story Matters”**

In many ways, homelessness isn't a problem to be fixed. More programs and housing aren't the silver bullets to solving this crisis in our communities. Unless we get to the crux of the cause of homelessness, we will always be putting on band-aids.

At Wichita Falls Faith Mission, we are passionate about the stories of our clients. We believe that unless you listen to their stories, find out what made them homeless in the first place and work to remedy that, you are only treating the symptoms. This is why, “Every Story Matters.”

**Steve Sparks** – Steve has been the CEO of Wichita Falls Faith Mission for 7 years. He was born and raised in Wichita Falls and married his High School sweetheart, Pam of 42 years. He has 3 children and 7 grandchildren. Steve served the local church as youth minister, associate pastor and worship leader around Texas and Louisiana. Before coming to Faith Mission, he was the Assistant Director at Camp Chaparral in Iowa Park.

Steve has a Bachelors in Education from Wayland Baptist University and a Master in Religious Education from Southwestern Baptist Theological Seminary. His mantra for serving at Faith Mission is, “Every person has a story and every story matters to God.”

## **“How Adults Learn: Understanding Eight Learning Styles of Adult Learners”**

How do adults learn? We all intuitively know that we learn in different ways. Some of us like to listen to an engaging presentation and others enjoy a lively discussion. Some adults enjoy interacting in a group and others prefer to reflect on new ideas alone. There are adults who want practical application and other adults who thrive on deep theory and ideas. This session will explore the cutting edge application of the Myers Briggs Type Indicator to adult learning styles through the work of Dunning Model of Adult Learning. If you are a counselor, consultant, educator, therapist or manager, you are in the business of impacting how adults learn and change. Come discover your own learning style and the styles of those you work with in this practical session.

**Don Hebbard, Ph.D.** – Dr. Hebbard is Professor of Counseling Human Behavior and Development at Amberton University. He is a Licensed Marriage and Family Therapist with 36 years' experience, and a Clinical Fellow in the American Association for Marriage and Family Therapy and in private practice in Dallas. Don has opened counseling centers, graduate programs and family institutes in Dallas, Atlanta and Oklahoma City. He travels nationally and is a popular speaker conducting seminars on relationships, leadership, transition and conflict resolution. He works with organizations that are experiencing transition in leadership assisting them through seminars and consulting.

## **“Helping People Change”**

Whether we are teachers, therapists, law enforcement specialists or involved in non-profit agencies we are in the business of helping people make changes in their lives. The challenge of this process is staggering. Why do some people change? Why do others stay stuck in patterns of self-destructive behaviors? How do we as agents of change assist people in the change process? This session will focus on the dynamic and often confusing process of individual transformation. We will look at signs of people who are going to stay stuck as well as key moments of opportunity where amazing breakthroughs can occur. When people make significant shifts, it can be an amazing process to watch.

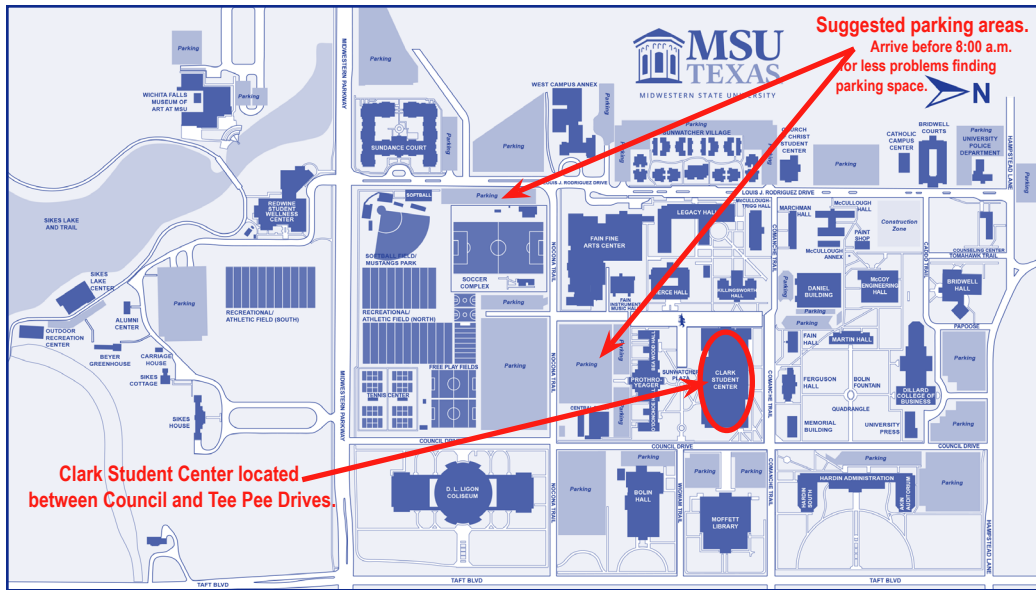

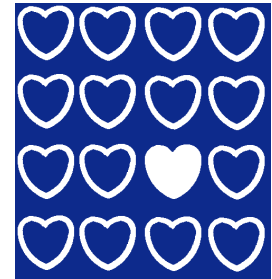
