1. Fill out an original I-765 (Make sure form is the most up-to-date from the USCIS website) . Access this form from:www.uscis.gov/forms

## Download and Open with Adobe Acrobat; TYPE AND PRINT FORM I-765

- Part 2. Your U.S. Mailing Address:

- Certification: Don't forget to provide your signature
- 2. Filing fee: \$ 410 USD (subject to change, check USCIS website) NO CASH
  - If using a U.S. based check or money order, make out to:
     "U.S. Department of Homeland Security"
  - Credit Card: Download and fill out the G-1450 from USCIS website
- 3. 2-Photos (passport style, 2 x 2, color, forward facing, white background, <u>less than 30 days old</u>) with your name and SEVIS ID written on the back. Try not to smear.

- 4. Copies of all previous I-20s from current education level.
- 5. Copy of passport (must include picture, name, and expiration date)
- 6. Copy of F-1 visa
- 7. Copy of most recent I-94 (electronic or card). Print web version from www.cbp.gov/i94.
- 8. Form G-1145 Type and print information (can also be accessed from <a href="www.uscis.gov/forms">www.uscis.gov/forms</a>)

## DURING OPT APPOINTMENT

- Review of your application materials including the OPT Waiver Form (university form, not to be sent to USCIS)
- An I-20 with OPT recommendation will be generated at appointment Student signature on page 1 & DSO signature on pages 1 & 2 Check page 2 for accuracy. (OPT recommended start date & end date)
- Complete OPT Applications will be sent to a USCIS Service Center. You will be responsible for paying for shipping and sending off your package to USCIS the same-day as your OPT appointment. Failure for your OPT application to be received by USCIS within 30 days of the I-20 generating OPT recommendation will result in denial of your OPT benefit request, which may have other negative consequences to your F-1 status.
