Welcome! Now that you have accepted employment at Midwestern State University, **you are responsible for reporting to Human Resources, Hardin Adm. Bldg., Room 210 prior to your first day of work to complete the employment process.**

The process is as follows:

Bring this notice to Human Resources along with the attached Form I-9 and bring **ALL** required documents. *Non-Resident Aliens on an F-1 Visa will need to visit the Office of International Services **FIRST** and then visit Human Resources with the Form I-9 and work documents listed below.

Appropriate documents may include one item from **List A:**

❖ **Examples:** US Passport, Foreign Passport w/I-94 form, Permanent Resident ID Card, Employment Authorization Card

Or, one item from **List B** and one item from **List C:**

❖ **Examples:** Driver's License, School ID Card with photograph,

❖ **Examples:** Social Security Card, United States Birth Certificate, US Military ID

Provide your original **Social Security Card** – you must show your SS card to Human Resources even if you choose not to use this card to complete the Form I-9. If you do not have a Social Security Card, please locate the nearest Social Security office.

Employees **will not be entered as an employee** until the Social Security Card has been presented to Human Resources. Your name for Payroll and Student Records will be exactly as it appears on your Social Security Card.

HIRING NEW EMPLOYEES

- Instruct new employees to bring the Form I-9 (with Section 1 completed), their employment documents, and the New Hire Authorization instruction form, to Human Resources prior to first day of work.
- **Inform new employees that they will be automatically terminated and no longer able to work if they do not provide documents to HR supporting the I-9 within 3 business days of their first day at work.**
- Back of the I-9 Form, a list is provided of the necessary documents needed to complete the form.
- International student employees must obtain a letter of authorization from International Services before they are allowed to begin working. They must bring their authorization letter to HR.
- The Form I-9 can be completed before the person has a Social Security Number by using other acceptable documents. Do **NOT** wait on the Social Security card to submit paperwork.
- **Employees will NOT be entered as an employee or processed through payroll and paid until the Social Security Card is provided.**
- Human Resources will enter the employee's information into the Federal E-Verify System, which verifies the person's documents with the US Customs and Immigration Service and the Social Security Administration records. This cannot be done until the Social Security Card is presented.
- HUMAN RESOURCES WILL SUBMIT THE **ORIGINAL EPAF FOR STUDENTS & TEMPS** AFTER THE PAPERWORK AND DOCUMENTS HAVE BEEN COMPLETED AND ENTERED INTO BANNER. *When an employee can clock in to work through Time Clock Plus, all documents have been received and an EPAF submitted.*
