**University Operating Policy/Procedure (OP) OP 74.09: Freedom of Expression** 

**DATE:** May 13, 2024

#### **PURPOSE:**

Midwestern State University ("MSU"), a component institution of the Texas Tech University ("TTU") System, recognizes freedom of speech and expression as a fundamental right and seeks to ensure free, robust, and uninhibited debate and deliberations by students enrolled at MSU as well as other persons. The purpose of this Operating Policy/Procedure ("OP") is to ensure the fundamental right of freedom of speech and expression on the MSU campus.

#### **REVIEW:**

This OP will be reviewed in September of odd-numbered years, or as needed, in consultation with the MSU Provost and Vice President for Academic Affairs, Vice President for Enrollment Management and Student Affairs, and MSU General Counsel, with substantive revisions forwarded to the MSU President.

#### **POLICY/PROCEDURE:**

Expressive activities on the MSU campus are governed by Texas Tech University System Regulation 07.04, which can be found <u>here</u>.
