I. Policy Statement and Purpose

Midwestern State University (“MSU” or “University”), a component institution of the Texas Tech University (“TTU”) System, is committed to the safety of its campus community and to complying with the requirements of the Stop Campus Hazing Act - Public Law 118-173 - passed by the 118th Congress of the United States and signed into law on December 23, 2024.
